

# Miss Pre-Teen Boyd County Fair Pageant Rules

1. The pageant is open to all Kentucky residents.
2. Pre-Teen Contestant must be 8 years of age by June 30, 2026 but NOT have reached their 13th birthday by October 31, 2026.
3. Teen Contestant must be 13 years of age by October 31<sup>st</sup> and not reached the age of 16 by October 31<sup>st</sup> 2026
4. Pre-Registration entry fee is \$40 paid prior to June 10, 2026. Registration will be accepted the day of pageant from 5-6:30 pm, late entry fee is \$50, cash only day of pageant. Copy of birth certificate is required.
5. The contestant must be a natural born female, single, never married, never had a marriage annulled, and never had any children.
6. Introductions will be in jean shorts and America/USA themed shirt or t-shirt..think America's 250<sup>th</sup> Birthday. Introductions will be followed by evening gown. There is no interview but there will be an onstage question during the evening gown section.
7. The winner will represent the Boyd County Fair in Louisville, KY at the fall meeting of the Ky Association of Fairs in October. Winners will receive a crown, sash, and \$100. Judges decisions are final. NO SCORE SHEETS WILL BE GIVEN
8. The contestant will be disqualified from the competition and forfeit any titles if information is falsified on application. Grounds for disqualification can be BUT are not limited to: untrue statements on registration forms, unruly behavior, misconduct, obscene, foul language and any other reason the pageant committee may deem as necessary.
9. Boyd County Fair winner must submit their paperwork to pageant coordinator no later than 20 days after pageant. If paperwork is not submitted during this time. The winner forfeits her title and all awards she received for the title. The first runner up will assume the title.
10. The Boyd County Fair, its affiliates or volunteers are in no way to be held responsible for any damages, thefts or accidents.
11. Due to the ever changing rules for social distancing, the Boyd County Fair reserves the right to adapt pageant to fit those guidelines.
